Wholespire has an agreement with the SC Department of Health and Environmental Control Division of Diabetes and Chronic Disease Prevention supporting diabetes prevention efforts outlined in the state health improvement plan. Wholespire is a subrecipient administering the grant with DHEC's Division governing the budget. Wholespire provides assistance with promotion of activities to support diabetes prevention including serving on the Diabetes Action Council and providing staffing support for the Council.

Teaming Up for Health Outcomes, a four-year coalition initiative, was launched in 2021 with support from the Blue Cross Blue Shield of SC Foundation, an independent licensee of the Blue Cross and Blue Shield Association. The initiative is a joint effort with the SC Office of Rural Health to help urban and rural coalitions improve population health by providing funding opportunities that focus on training, coaching, capacity building, and healthy eating active living improvement projects.
