Wholespire has an agreement with the SC Department of Public Health (DPH) Diabetes and Heart Disease Management Section to work to address diabetes disparities among selected priority populations to include serving as a resource to address social needs and social determinants of health (SDOH). Wholespire assists the Section with data collection efforts to include identifying and interviewing priority populations and conducting focus groups. In addition, Wholespire, Inc. works with the Section to find and contract with content experts to conduct landscape assessments, raise awareness among providers about the value of integrating Community Health Workers (CHWs) into health care teams to reduce health disparities, and facilitate focus groups. Wholespire is a subrecipient administering the grant with DPH's Section governing the budget.
